

ENGAGE.EU Grant 2025

With ENGAGE.EU we want everyone to have the opportunity to experience Europe. The Foundation of the University of Mannheim supports this experience by providing ENGAGE.EU Grants to students who, for personal, economic, or health-realted reasons, are unable to participate in the education and mobility programmes of the ENGAGE.EU partner universities.

Target group

Students who, for personal, economic, or health-related reasons, cannot take part in educational and mobility programmes offered by ENGAGE.EU partner universities.

Grant

Students can apply for a one-time travel and accommodation grant for participation in events organized by the ENGAGE.EU partner universities (e.g., workshops, summer schools). The maximum duration of eligible events is two weeks, and the amount of the grant depends on the country of travel¹. In addition, a grant can be requested to cover the participation fees to the extent of 50% of the total amount and up to a maximum of 500 EUR.

Prerequisites

Candidates must meet the following requirements:

- enrolled in a bachelor's or master's programme at the University of Mannheim;
- good knowledge of English (at least B2);
- facing personal, economic or health-related difficulties.

Required documents

Applicants must submit the following documents in English:

- Letter of motivation incl. self-description of personal, economic or health-related circumstances (max. 1 DIN A4 page);
- Curriculum vitae;
- University entrance qualification;
- Certificate of enrollment;
- Declaration of consent to the processing of personal data.

WHICH TYPES OF PERSONAL DATA ARE PROCESSED?

We process the personal data that are send to us that are relevant for assessing your application and in case of selection for payment of the ENGAGE.EU Grant.

FOR WHICH PURPOSES DO WE PROCESS YOUR DATA?

We process your personal data for assessing, deciding on, and processing of your application for the ENGAGE.EU Grant, as well as for sending data to the Foundation of the University of Mannheim for payment in case of selection (name, contact and bank details).



WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR DATA?

• Art. 6 (1) item a of the GDPR – consent

You can withdraw your consent to any future data processing at any time by sending a written notice at any time without having to state any reasons to the university's ENGAGE.EU Management Office (engage@uni-mannheim.de). However, any processing of your data which occurred before consent was withdrawn remains legal and unaffected. If you withdraw your consent, all data processing activities will be stopped immediately once we receive your notice of withdrawal of consent, and the data on which these activities were based will be deleted. Withdrawal of consent by the applicant and the resulting deletion of the applicant's personal data will lead to the termination of any decision-making procedures that may have been initiated for assessing the application.

ARE YOU OBLIGATED TO PROVIDE YOUR PERSONAL DATA?

For us to be able to assess grant applications, it is necessary that you provide the data we need to assess your application. Also, the Foundation of the University of Mannheim needs the corresponding data to process the payment of the ENGAGE.EU Grant in case of selection.

TO WHICH OTHER PARTIES DO WE PASS ON YOUR DATA?

Data which are necessary to process payment (name, contact and bank details) will be send to the Foundation of the University of Mannheim which funds the ENGAGE.EU Grant.

HOW LONG DO WE STORE YOUR DATA?

The University of Mannheim will delete the personal information when the application process is performed.

WHAT ARE YOUR RIGHTS AS A DATA SUBJECT?

- You have the right to obtain information about your data stored by the University of Mannheim and the right to have false data rectified.
- Furthermore, you have the right to erasure, the right to restriction of processing, the right to data portability and the right to object to the processing.
- In case you gave consent to further optional cases of processing, you can withdraw your
 consent (completely or for individual cases of processing) at any time. The withdrawal of
 consent does not affect the lawfulness of processing based on consent before its withdrawal.
