

Information on the Application Process for the Fall Semester 2021/2022 for Master's Programs at the University of Mannheim

With the statutes dated 11 March 2021, the application process for the fall semester 2021/2022 has been adapted to the challenges posed by the current coronavirus pandemic. Therefore, in deviation from the regulations on admission and enrollment (ZullmmaO) of the University of Mannheim and all program-specific regulations on admission or selection statutes, the **following provisions will apply for the fall semester 2021/2022** to all consecutive and non-consecutive master's programs:

Section 1 - Changes to Formal Requirements

1. For the fall semester 2021/2022, the application for admission form **must be submitted electronically in the form required by the University of Mannheim**. A **personal signature is not required**. All additional documents relating to admission requirements and selection criteria must be submitted during the application process **as electronic copies only, in a file format and in the form approved by the university**. No documents shall be submitted in print format unless the university expressly requests hard copies. If it is not possible to submit the application electronically due to hardship, an alternative way of transmission may be permitted upon request.
2. This form shall also apply to applications for the selection according to hardship criteria and for the selection of applicants who are locally bound in the public interest (top-level athletes) as well as for non-selective programs.
3. Admission may be denied if the documents do not meet the requirements of the University of Mannheim; this includes the form of the documents. **The University of Mannheim may request that the original or a notarized copy of the documents listed in subsection 1 be presented upon enrollment**.
4. The scope of the documents to be submitted remains unchanged.

Section 2 - Postponement of the Application Deadline

For the master's programs **Intercultural German Studies, Political Science, Sociology, and Economics** the application deadline for the fall semester 2021/2022 is postponed: Applications for participation in the selection process and admission to the fall semester 2021/2022 must be submitted by **31 May 2021 (definitive deadline)**.

Section 3 - Other Temporary Changes

In the application process for the fall semester 2021/2022, there is no voluntary admission test for the Master of Science in Psychology ("Work, Economy and Society") and Master of Science Psychology ("Cognitive and Clinical Psychology") programs; therefore, no additional points will be awarded for this criterion; the maximum number of points achievable in the selection process is thus limited to 50 points.

Please note:

The aforementioned changes are **NOT** included in the following non-official version. **The temporary changes deviating from the regular statutes shall apply only once to the fall semester 2021/2022 due to the challenges posed by the coronavirus pandemic.**

Selection Statutes for the Master's Program

Economics

as at 10 December 2020

Based on section 59 subsection 1 sentence 2, section 63 subsection 2 of the act on the higher education institutions in the Land of Baden-Württemberg (Landeshochschulgesetz, LHG), section 6 subsection 4 sentence 5 in conjunction with subsection 2 sentence 12 and section 2c sentences 2 and 3 of the act on the admission to higher education institutions of the Land of Baden-Württemberg (Hochschulzulassungsgesetz, HZG) as well as section 33 subsection 1 sentence 2, subsection 2 sentence 5 of the act on the admission to higher education institutions in the Land of Baden-Württemberg (Hochschulzulassungsverordnung, HZVO) the Senate of the University of Mannheim passed the following Selection Statutes for the Master's Program in Economics in accordance with section 19 subsection 1 sentence 2 number 10 LHG on 9 December 2020.

Section 1 – Scope

(1) ¹If there are more applicants than study places for the abovementioned degree program, the University of Mannheim conducts its own selection process in accordance with the regulations of higher-ranking legislation. It is governed by these Statutes. ²The decision is made in consideration of the applicants' aptitude for the degree program and the typical subsequent profession.

(2) ¹Sections 2 to 4 of these Statutes apply to all applications regardless of whether or not there is a limited number of study places or a selection procedure takes place; section 37 subsection 1 HZVO and section 6 subsection 3 sentence 4 of the regulations on admission and enrollment (Zulassungs- und Immatrikulationsordnung der Universität Mannheim, ZullmmaO) remain unaffected. ²An impediment to admission in accordance with section 4 subsection 2 number 2 clause 2 is also considered an impediment to enrollment. ³By way of derogation from section 4 subsection 3, all decisions must be made by the examination committee responsible for the master's program in Economics instead of the admissions committee if no selection process takes place.

(3) The regulations on admission and enrollment of the University of Mannheim (ZullmmaO) remain unaffected in its valid version unless determined otherwise in these Statutes.

Section 2 – Deadlines

(1) Applications for admission for the fall semester must be submitted by 30 April of each year (definitive deadline).

(2) In case of an application for the fall semester, proof of English proficiency can be submitted until 15 August of the same year (definitive deadline).

Section 3 – Form of the Application

(1) ¹The application for admission form must be submitted electronically in the form required by the University of Mannheim via the web portal; additionally, the documents listed in subsection 2 must be sent in print format. ²If it is not possible to submit the application electronically due to hardship, the application may be submitted in writing or verbally on record upon request.

(2) In addition to the electronic application in accordance with subsection 1, the following documents must be sent in print format:

1. the signed application for admission form,
2. documents of proof in accordance with section 7 subsection 1 numbers 4, 5, 8 to 10 ZullmmaO,
3. documents of proof that the admission requirements listed in section 4 are met,
4. documents of proof that the selection criteria listed in section 7 are met.

(3) The University of Mannheim may request that applicants submit originals or notarized copies of the documents listed in subsection 2; originals or notarized copies may be required in particular for application for admission forms.

Section 4 – Admission Requirements

(1) Applicants for the master's program in Economics have to meet the following admission requirements:

1. ¹Applicants are required to have a bachelor's degree in Economics or a degree recognized by the admissions committee as equivalent from a German or foreign higher education institution or an officially recognized public university of cooperative education (Berufsakademie). ²The bachelor's degree must correspond to at least 180 ECTS credits or have a standard period of study of at least 6 semesters or 3 years. ³The final grade of the degree must be at least 2.5; clause 1 applies correspondingly to the current average grade of the bachelor's program in accordance with section 7 subsection 1 number 1.

2. ¹Applicants have to provide proof of sufficient English proficiency. ²The successful completion of a program of study with English as language of instruction and examination of at least 25% of the courses and examinations or a University Entrance Qualification (HZB) from a school with English as the language of instruction serves as proof. ³If an applicant has obtained neither of the above, the following test results can serve as proof of English proficiency:

- a) certificate of the Test of English as a Foreign Language Internet Based Test (TOEFL iBT) with a score of at least 72 points; TOEFL MyBest scores are not accepted,
- b) First Certificate in English (FCE) with Level C or better,
- c) Certificate in Advanced English (CAE),
- d) Certificate of Proficiency in English (CPE),

e) International English Language Testing System – Academic Test (IELTS) with a band score of 6.0 or better.

f) Certificate of the language test offered by the "Universität Mannheim Service and Marketing GmbH" with a minimum level of B2 in listening comprehension, written language, spoken language and reading comprehension.

⁴Only test results obtained no more than five years prior to the deadline in accordance with section 2 subsection 1 will be recognized as proof. ⁵Any other type of documents serving as proof of an applicant's English proficiency will be considered sufficient if they can be recognized as equivalent.

(2) Applicants are eligible for admission to the master's program in Economics if they meet the following additional admission requirements:

1. ¹Submission of the application in due time and form. ²If the bachelor's degree in accordance with subsection 1 number 1 has not been completed by the end of the definitive deadline defined in section 2 subsection 1 due to the fact that individual examinations have not been completed and it is anticipated that the degree will be completed in due time before the beginning of the master's program in Economics, admission may be requested provided the applicant is able to prove completion of at least 120 ECTS credits. ³Within the definitive deadline defined in section 2 subsection 1, proof of the credits earned must be submitted. ⁴In this case, admission is subject to the proven completion of the bachelor's degree in accordance with subsection 1 number 1 by the date defined in the official letter of admission or by the first registration for an exam at the latest. ⁵If proof is not provided in due time, admission to the master's program will be rescinded.

2. There may not be any impediments to admission; a particular impediment exists if an applicant has lost their eligibility to take exams in the same program or a program in a similar field of study; section 7 subsection 1 number 5 ZullmmaO remains unaffected.

(3) ¹The admissions committee decides whether a degree or a qualification is considered equivalent or comparable and thus meets the admission requirements. ²The School of Law and Economics guarantees a consistent procedure, in particular if more than one admissions committee was formed. ³For the recognition of foreign degrees, the recommendations of the Standing Conference of the Ministers of Education and Cultural Affairs as well as cooperation agreements between universities must be taken into account. ⁴In cases of doubt, the Central Office for Foreign Education (Zentralstelle für ausländisches Bildungswesen - ZAB) is consulted.

Section 5 – Admissions Committee

(1) ¹The School of Law and Economics appoints at least one admissions committee for the preparation of the selection process. ²It is composed of at least two members. ³The members of an admissions committee must be staff members whose main employer is the university. At least one member must be a university teacher. ⁴The committee members' term of office is two years. ⁵They may be reappointed.

(2) Upon completion of the selection procedure, the admissions committee reports its experiences to the school council of the School of Law and Economics and makes suggestions for the further development of the selection procedure.

(3) The admissions committee may consult up to two additional people familiar with the relevant program of study; these people do not have a vote.

Section 6 – Selection Process

(1) ¹The admissions committee selects potential students based on the selection criteria of section 7 and prepares a ranking. ²The President of the university decides which candidates will be admitted. This decision is based on the recommendations of the admissions committee.

(2) Admission is denied if the applicant is excluded from the admissions process due to higher-ranking law, especially if the documents as laid out in section 3 subsection 2 were not submitted in due time and form by the definitive deadline as stipulated in section 2 subsection 1 or if another impediment to admission exists.

Section 7 – Selection Criteria and Preparing a Ranking

(1) The admissions committee takes the following criteria into account when preparing a ranking in the selection process:

1. the final grade or the current average grade of the bachelor's program according to section 4 subsection 2 number 1,
2. the letter of motivation written by the applicant,
3. the academic paper written by the applicant (essay).

(2) Each applicant receives a score for each selection criterion according to the following regulations; the admissions committee evaluates the submitted documents:

1. ¹For the final grade or the current average grade of the bachelor's program according to section 4 subsection 2 number 1 a maximum of 15 points may be given. ²The grade, including the first decimal, is translated into points. ³15 points may be given for the grade 1.0 and 0 points may be given for the grade 2.5. ⁴The points for the remaining grades in between are calculated linearly in steps of 0.1 and rounded. ⁵If the higher education institution at which the applicant is pursuing their bachelor's degree does not provide the current average grade, the average grade is calculated from all module grades or examination grades weighted in ECTS credits the applicant has achieved in the course of their bachelor's program up until the selection process. ⁶If the final grade or average grade is indicated in a grading system which does not correspond to the grading system used for the bachelor's programs of the School of Law and Economics of the University of Mannheim, the grade is converted according to the recommendations of the ZAB.
2. ¹For the letter of motivation written by the applicant a maximum of 5 points may be given. After the evaluation of the overall impression of the letter comprising the form and the conclusiveness of the motivation for choosing the program, a very good letter receives 5 points, a good letter 3 points and a satisfactory letter 1 points. ³The letter of motivation includes the applicant's motivation for a master's program in Economics at the University of Mannheim, the planned specialization during the program and the applicant's plan for their professional future.

Furthermore, the applicant must explain the connection between their first degree and the chosen master's program. ⁴The letter of motivation must be written in German or English and must not exceed 2 DIN A4 pages using font size 12; if the letter of motivation exceeds the maximum length, only the first 2 pages will be taken into account. ⁵The motivation letter will be evaluated by the admissions committee on the basis of the recommendation of a university teacher from the Department of Economics; the admissions committee determines the responsibilities.

3. ¹For the essay written by the applicant a maximum of 10 points may be given. ²In the essay, a topic from the area of Economics, Econometrics, Economic History or Statistics must be covered and/or quantitative methods must be applied. ³A very good essay receives 10 points, a good essay 5 points and a satisfactory essay 1 point. ⁴The essay must be written in German or English and must not exceed 25 DIN A4 pages using font size 12; if the essay exceeds the maximum length, only the first 25 pages will be taken into account. ⁵The essay will be evaluated by the admissions committee on the basis of the recommendation of a university teacher from the Department of Economics; the admissions committee determines the responsibilities.

(3) ¹In accordance with subsection 2 numbers 1 to 3, the points are added up; the maximum score is 30 points. ²Based on the score the applicants are ranked in descending order. ³In cases where applicants achieve the same score, selection is based on the average grade that was achieved in the degree that is required for admission to the master's program in Economics; if applicants then have the same score, selection is decided by lot.

(4) In order to guarantee a consistent procedure, the school council of the School of Law and Economics can pass additional regulations for the consideration of proofs for individual selection criteria, in particular for the conversion of grades; the admissions committee is bound by these regulations.

Section 8 – Commencement; Final Provisions

(1) ¹These Statutes will come into effect on the day after their publication in the general section of the Bulletin of the President's Office (Amtliche Bekanntmachungen des Rektorats). ²During the admissions process for the fall semester 2021/2022 they are applied for the first time.

(2) At the same time the Selection Statutes for the Master's Program in Economics of the University of Mannheim as at 14 April 2009 (Bulletin of the President's Office (Amtliche Bekanntmachungen des Rektorats) No. 11 of 22 April 2009, p. 13), last amendment of 24 April 2015 (Bulletin of the President's Office (Amtliche Bekanntmachungen des Rektorats) No. 12/2015 as at 28 April 2015, p. 7) cease to be effective. ²Admissions processes that are not yet completed by the time of the commencement of these Selection Statutes are to be concluded on the basis of the former valid selection statutes.
