## **Professor Imelda Maher (UCD)**

Professor Imelda Maher, MRIA is the Sutherland Full Professor of European Law.

Currently Senior Vice President of the Royal Irish Academy and Director of the UCD Dublin European Institute, she researches and teaches on EU Law and Governance.



## Doctor Maria Patricio-Mulero (UTC/UT2J)
